Following is an application for membership in CCMORF and an application for a South Texas PHRF rating. Please note that membership in CCMORF is for a calendar year. Membership will expire on December 31<sup>st</sup>, and membership fees are not prorated.

CCMORF has two levels of membership: Regular and Supporting. Members who own a boat that they wish to race in CCMORF events must join at the Regular level and complete both the membership and the PHRF applications below. Members who do not own a boat that wish to race in CCMORF events and who do not need a South Texas PHRF rating may join at the Supporting level. Supporting members need only complete the membership application.
